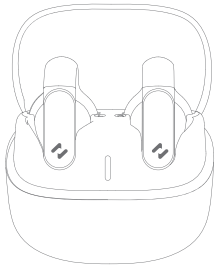
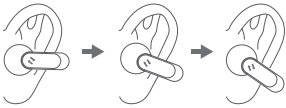
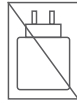

Activate the phone's Bluetooth-connection function and search for "HAVIT OPENBUDS 1" referring to your phone instructions.Click "HAVIT OPENBUDS 1" to connect.<br/>3. The earbuds can automatically reconnect with the last device that you had paired. "HAVIT OPENBUDS 1" will disconnect when leaving the working range of Bluetooth.
