

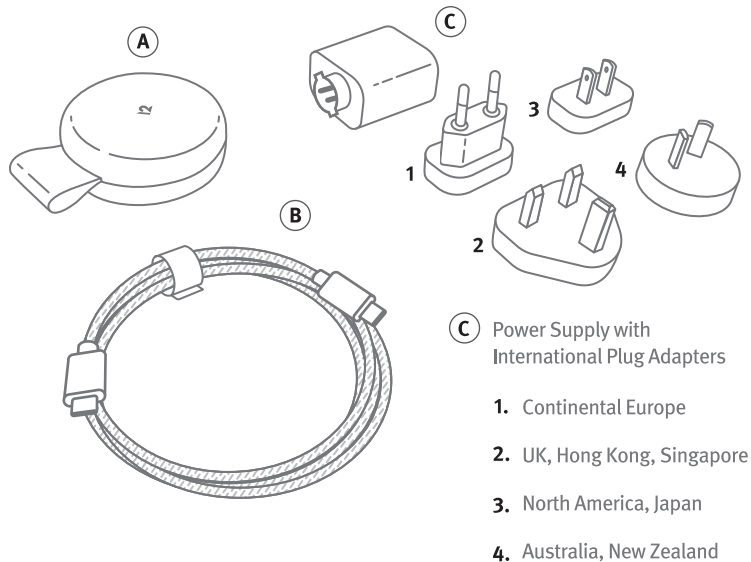

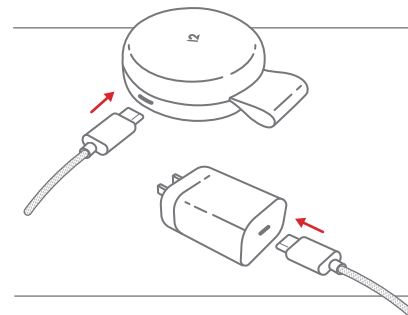
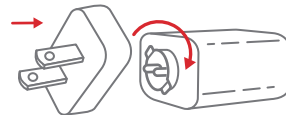
What's in the box:

Getting Started:

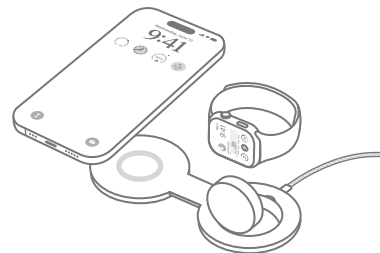
Choose your appropriate **International Plug Adapter**, slide it onto the **Power Supply** and twist until it locks into place.



Plug the **USB-C Cable** into the port on the **Power Supply** and **ButterFly**.

Plug Power Supply into nearby wall outlet.

Open **ButterFly**, and place devices on top to begin charging.

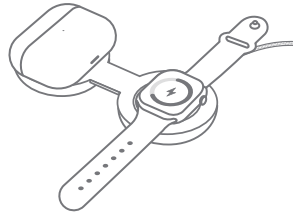

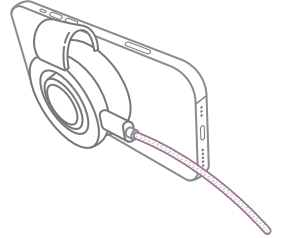
